Barricades/Safety Cones:

- Organizations may rent barricades and/or safety cones from the City of St. Cloud Public Works Department.
- Sponsoring organization will receive six (6) barricades or forty (40) safety cones for the minimum fee of \$20.00. Each additional barricade costs \$3.00 and each additional safety cone costs 50 cents. Delivery and pickup of barricades/safety cones is available for an additional \$40.00. These fees only apply to neighborhood events and private parties. Major events including bike races, parades, marathons, etc. that involve closing public roads and/or sidewalks require additional equipment and will be charged accordingly.
- Sponsoring organization must pick up the barricades and/or safety cones from the Public Works Department, 1200 15th Avenue South East, St. Cloud.
- Please contact the Public Works Department at 320-650-2900 at least 48 hours prior to picking up barricades and/or safety cones. City equipment must be returned the next working day.
- Sponsoring organization will be responsible for any damage to City equipment and will be charged for the cost of replacement.
- City equipment must be paid for at the time it is picked up at the Public Works Department.
- A copy of the approved application for a parade, run/walk or block party must be presented at the time the equipment is picked up.
- The Public Works Department does not guarantee the availability of equipment unless the sponsoring organization has contacted the Public Works Department.
